



Program Sponsorship

\$5,000 SUMMER PROGRAM SPONSOR *

Funds scholarship assistance for school age and/or preschool children of low income parents who need extra assistance while school is out. This is a critical need for working parents to remain employed.

\$4,000 NURSING PROGRAM SPONSOR *

We assist many people who are not served anywhere else because of their needs for medication, g-tube feeding, ability to staff for major seizure disorders, lifting and transfer etc. State funding does not adequately serve these needs. This sponsorship covers approximately one month of staffing.

\$3,500 TRANSPORTATION SPONSOR *

Our handicap accessible busses are key to our ability to serve our families, providing home pick up and drop off, before and after school transports and activity transportation for youth and adults. Fuel and maintenance are huge expenses.

\$2,500 RESPITE CARE SPONSOR *

Provides scholarship funding for low income families for multiple care needs including emergency help (days, evenings or overnight).

\$2,500 FAMILY PROGRAM SPONSOR *

Provides workshops and fun activities that involve siblings and parents groups. Examples include visiting petting zoo, special art projects or theatre presentation.

\$2,000 FAMILY PLACEMENT SPONSOR *

Helps us provide our Foster, Adopt and Host Home programs assistance with special family needs.

\$1,000 ACTIVITY & OUTING SPONSOR *

Provides youth and/or adults with funding for YMCA swimming, community visits and other enrichment activities.
